### Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [Office for Victims of Crime](#) (OVC) seeks applications that demonstrate innovative strategies to create, expand, or enhance the use of technology to interact directly with crime victims or to provide information, referrals, crisis assistance, and long-term help. This program furthers the DOJ's mission by supporting organizations that encourage the use of technology to improve responses, services, and access for victims of crime.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#) which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, State governments

An applicant entity may submit more than one application, if each application proposes a different project in response to the solicitation. Also, an entity may be proposed as a subrecipient (subgrantee) in more than one application.

OVC will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the [OJP Grant Application Resource Guide](#).

OVC may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

## Submission Information

## Program Description

### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, OVC seeks to provide funding to organizations that demonstrate innovative and effective strategies to create, expand, or enhance the use of technology to increase access to and quality of services for victims of crime and improve the accessibility and responsiveness of victim service organizations.

### Statutory Authority

34 U.S.C. § 20103(c)(1)(A)

### Specific Information

The 2021 Criminal Victimization report from the [Bureau of Justice Statistics](https://bjs.ojp.gov/content/pub/pdf/cv21.pdf) shows that 46 percent of victims of serious violence reported incidents to the police, but only 9 percent of them received victim assistance from a victim services agency. (Note: see Thompson, A. & Tapp, S.N. (2022, September). Criminal Victimization, 2021. *Bureau of Justice Statistics*. <https://bjs.ojp.gov/content/pub/pdf/cv21.pdf>.)

Without access to a range of quality support services such as crisis assistance, mental health support, or financial assistance, victims may not receive the help they need to heal.

To reach more victims and ensure access to services, OVC encourages the use of technology to respond to the needs of victims and expand on the successful growth in technological capacity to provide victim services. Through this program, OVC will support national-scope and regional initiatives (that can be replicated nationally) that maximize the use of technology to increase access to victim services and information about victims' rights, improve the quality of services, and strengthen the responsiveness of victim service organizations.

Funding under this initiative may support technology development and maintenance to facilitate efficient service delivery or communication; staff required to operate, update, and maintain the proposed technology platform or service; training and technical assistance on the purpose and use of the technology (including outreach and public awareness activities); and staff engaged in coalition-building and outreach activities regarding the use of technology.

This funding should not supplant or duplicate currently funded initiatives in these areas. Applicants who propose to use this funding for ongoing, rather than new, initiatives must specify how these funds would be used to *expand or enhance* current services rather than duplicate or continue existing efforts.

## **Goals, Objectives, and Deliverables**

### **Goals**

The goals of this program are to increase greater access to victim services and build the technological capacity of victim-serving organizations to meet the needs of crime survivors through innovative solutions and trauma-informed approaches.

### **Objectives**

An applicant should address the objectives listed below in the Goals, Objectives, Deliverables and Timeline web-based form.

1. Conduct strategic planning activities to identify gaps in technology that can be enhanced by building the organization's technological capacity to ensure greater access to victim services that are sustainable, secure, and safe.
2. Implement technological enhancements to strengthen the organization's response to crime victims and ensure high-quality services that are trauma-informed, culturally responsive, and centered in victim safety, confidentiality, and privacy.
3. Prepare and support staff through training on the technology platform and the organization's confidentiality and privacy guidelines, appropriate to the services provided and populations served.
4. Collaborate with local, state, and community stakeholders to ensure greater coordination of services.
5. Conduct training and public awareness activities for professionals and community members to ensure appropriate education and awareness of the proposed technology platform or program services and resources.
6. Perform data collection and participate in evaluation activities to determine the effectiveness of the program and whether it is meeting stated goals and objectives.

### **Deliverables**

The deliverables can be web applications (apps), management information systems, interactive websites, or any improvement or enhancement that uses technology to provide the service or support the program. Other deliverables must include the following:

- Criteria to best determine strategies and effective collaborative models for planning, implementing, and evaluating the proposed technological innovations in the community, state, or region.



- Development of a staff training plan.
- Development of outreach and public awareness strategies.
- Development of a training and technical assistance plan for participating organizations.
- Development of an evaluation plan to measure project effectiveness in achieving the project goals, objectives, and identified outcomes.
- Signed Letters of Support or Memoranda of Understanding (MOU) with key implementation partners.
- Development of a public-facing report that highlights data collected about the specific service responses to meet the needs of victims of online harassment and abuse and recommendations to address any gaps in services (*Applicable to Priority Area 2A applicants*).

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

### **For Programs Serving Children and Youth**

If your program provides services to child and youth victims of crime, services must be tailored to ensure that they are developmentally appropriate, culturally responsive, victim-centered, and trauma-informed. Programs are expected to engage in practices that remove barriers to receiving services and support survivor autonomy. For youth-serving programs with justifiable mandatory requirements, a [shared decision making model](#) should be used to provide minors with agency in participating in decisions that impact them. OVC encourages the use of evidence-based and evidence-informed practices when working with children and youth victims of crime.

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted

by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

In support of this [Executive Order](#), OJP will provide priority consideration when making award decisions to the following:

A. Applications that propose project(s) that are designed to promote racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential racial inequities and contribute to greater access to services and opportunities for communities that have been historically underserved, marginalized, and adversely affected by inequality, and identify how the project design and implementation will specifically incorporate the input or participation of those communities and populations disproportionately impacted by crime, violence, and the criminal justice system overall. Examples addressing this requirement include, but are not limited to, the following: budgeted project planning and/or implementation meetings with community stakeholders representing historically underserved and marginalized communities; outreach and/or public awareness campaigns specifically tailored to historically underserved and marginalized communities to encourage participation in the proposed project(s); budgeted incorporation of members representing historically underserved and marginalized communities in program evaluation, surveys, or other means of project feedback; and partnership with organizations that primarily serve communities that have been historically underserved, marginalized, and adversely affected by inequality.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people,

Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

2. In support of the [Memorandum on the Establishment of the White House Task Force to Address Online Harassment and Abuse](#), OVC will provide priority consideration when making award decisions to the following:

A. Applications that propose innovative uses of technology to increase safety and access to support services for those who experience online harassment and abuse at the intersection of misogyny, racism, and homophobia, particularly toward women and girls along with LGBTQ and nonbinary people and other marginalized groups. Online harassment and abuse may include nonconsensual distribution of intimate digital images; cyberstalking; sextortion; doxing; malicious deep fakes; gendered disinformation; the online recruitment and exploitation of victims of sex trafficking; rape and death threats; and various forms of technology-facilitated intimate partner abuse.

To receive this consideration, the applicant must (1) describe how it will address the specific needs of victims of online harassment and abuse, including their safety, and (2) increase programming and resources that respond to victims of online harassment and abuse.

Note: Addressing these priority areas is one of many factors that OJP considers in making funding decisions. Receiving priority consideration for one or more priority areas does not guarantee an award.

If OJP determines that an application does not include these elements, it will neither proceed to peer review, nor receive further consideration.

### **Information to Complete the Application for Federal Assistance (SF-424) in Grants.gov**

### **Proposal Abstract**

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the [OJP Grant Application Resource Guide](#) for an example of a proposal abstract. If priority consideration is being requested, please indicate the priority area(s) (1A, 1B, and/or 2A) selected.

### **Proposal Narrative**

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 25 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, OVC may consider such

noncompliance in peer review and in final award decision. Tables, charts, and graphs included in the program narrative can be created in a legible font smaller than 12-point and will count toward the page limit.

The Proposal Narrative must include the following sections:

a. Description of the Issue

- Describe why this project/these proposed activities are necessary (significance/value) or address a need. Include supporting information.
- Describe how funding will support the project's value to the victims field by meeting the stated goals. An applicant should use data to provide evidence that the need for the effort exists and demonstrate the scope and size of the need. The applicant should also make a convincing case that the project addresses a gap in existing resources and does not duplicate an existing program.

b. Project Design and Implementation

- Describe the strategy to address the needs identified in the Description of the Issue.

### Review, Certify and Submit Application in JustGrants

- Any validation errors will immediately display on screen after submission.
- Correct validation errors, if necessary, and then return to the “Certify and Submit” screen to submit the application. Access the [Application Submission Validation Errors Quick Reference Guide](#) for step-by-step instructions to resolve errors prior to submission.

- Once the application is submitted and validated, a confirmation message will appear at the top of the page. Users will also receive a notification in the “bell” alerts confirming submission.
