



## Training & Technical Assistance

HTD grantees can access several types of training and technical assistance (TTA) providers to support their program and their staff across the life of their award.



### Program TTA

TTA specific to a program funded by OVC. This TTA focuses on helping you accomplish the goals, objectives, and deliverables outlined in your solicitation.

### Specialized TTA

Subject specific or area specific TTA. This allows grantees to receive additional support across programs focused on a specific topic.



### Operational Support TTA

This TTA offering is focused on supporting the administrative and financial components of managing a federal award. This supports grantees in capacity building for their organization.

# **Translating into Practice**

Procedures and Policies that provide <u>*all*</u> survivors access to assistance

Procedures or policies that protect the confidentiality of information and/or privacy of persons receiving services.

Procedures or policies that do not require victims to take certain actions to be eligible for, or to receive services.

Projects that consider the unique needs of individuals with disabilities, with limited English proficiency, or who are Deaf or hard of hearing, including accessibility for such individuals.




## Human Trafficking Victim Justice Program Specialist

- Help your organization successfully navigate the onboarding process.
- Answer administrative and programmatic questions and concerns.
- Address questions about award conditions.
- Review all Grant Award Modifications (GAM) in JustGrants, address concerns, and move forward for final OVC approval.
- Work with you to ensure programmatic and/or financial changes are appropriately documented.
- Work with your TTA provider to ensure you are receiving requested training and technical assistance.
- Inform you of OVC events and online resources to support your programmatic requirements.
- Consult with your team on any programmatic changes.

### Human Trafficking

### **Overview** S

Human trafficking, also known as trafficking in persons, is a crime that involves the exploitation of a person for the purpose of compelled sex or labor.

There is no single profile of a trafficking victim.

Victims of human trafficking can be anyone—regardless of race, color, national origin, disability, religion, age, gender, sexual orientation, gender identity, socioeconomic status, education level, or citizenship status.

Any person under the age of 18 who is engaged in commercial sex acts, regardless of the use of force, fraud, or coercion, is a victim of human trafficking, even if they appear to consent to the commercial sex act. Learn More.

From October 2022 through September 2023, 249 OVC human trafficking grantees provided services to 7,755 clients on average per quarter. <u>Learn More</u>.

Grantees are expected to be familiar with-

- the program requirements detailed in the fiscal year solicitation under which the award was made, and
- the terms and conditions contained in their award documents.

Simply stated: when in doubt, refer to the solicitation and your award documents.

The solicitation may outline specific allowable and unallowable costs and activities, and the award conditions detailed in the award documents will provide further guidance about programmatic requirements.

Grantees should read the solicitation and review the award conditions in <u>JustGrants</u> before consulting their OVC grant manager.

### Human Trafficking Grantee Performance Measures &

OVC strives to uphold the intent of the Trafficking Victims Protection Act of 2000 and its subsequent reauthorizations to ensure that all trafficking victims—regardless of immigration status, gender, or form of trafficking—receive justice and support in accessing the services they need.

OVC manages the largest amount of funding across the Federal Government dedicated to providing services to victims of human trafficking. OVC strengthens the response to human trafficking through grant funding for victim services, multidisciplinary teams, statewide responses to child and youth trafficking, training and technical assistance, and leadership in the field.

In 2020, all performance measures across the OVC human trafficking portfolio were revised to—

- · better reflect and report the activities of OVC's human trafficking grantees,
- standardize the questions across OVC's human trafficking portfolio, and
- align the human trafficking performance measures to OVC's other performance measures.

Data from the revised performance measures allow OVC to communicate to its stakeholders the full picture of the benefits realized with OVC grant funds.


