



Report on the OVC Fiscal Year 2023 Crime Victims Fund Tribal Set-Aside Program

INTRODUCTION

The U.S. Department of Justice (the Department) has a long-standing commitment to improve services for victims of crime in American Indian and Alaska Native communities. Since Fiscal Year (FY) 2018, the Office for Victims of Crime's (OVC) Tribal Division has administered the "Tribal Set-Aside" from the Crime Victims Fund (CVF) to fund the Tribal Victim Services Set-Aside Formula Grant Program (TVSSA Program). In January 2024, the Department will consult with Tribal leaders about the "Tribal Set-Aside" funding and other Tribal-specific grant programs. OVC presents this report to detail how Tribal Set-Aside funds were obligated in FY 2023.

HISTORY OF THE OVC TRIBAL SET-ASIDE PROGRAM

FY 2018-2019: Creation of the Tribal Set-Aside, Competitive Award Process

A 1988 amendment to the Victims of Crime Act of 1984 (VOCA) created OVC as part of the Department's Office of Justice Programs. An important part of OVC's mission is to administer grant awards that are funded by the CVF, which primarily includes criminal fines and fees paid by persons convicted in federal courts. Each year Congress authorizes OVC to use the CVF to support grant programs for victim services. The amount of funds authorized to be spent is referred to as "the cap." In the FY 2018 budget, Congress created the first Tribal Victim Services Set-Aside from the CVF cap. The amount of the first set-aside was 3 percent, totaling about \$133 million "available to the Office for Victims of Crime for grants, consistent with the requirements of the Victims of Crime Act, to Indian tribes to improve services for victims of crime." In the FY 2019 budget, Congress authorized a Tribal Set-Aside of \$167.65 million (5 percent), for the same purposes. OVC distributed the FY 2018 and FY 2019 set-asides as competitive discretionary grant award programs with a 36-month project period to all eligible applicants, which included federally recognized Indian tribal governments, legal entities acting as the authorized designees of federally recognized Indian tribes, and tribal consortia made up of two or more federally recognized Indian tribes.

FY 2020: Introduction of the Tribal Set-Aside Formula Grant Program

Congress authorized a 5 percent Tribal Set-Aside from the CVF cap for FY 2020, resulting in a total of \$132.05 million for distribution to eligible applicants. In response to feedback received from Tribal leaders and representatives at tribal consultations and Federal Advisory Committee meetings that Tribes did not want to compete for set-aside funds, OVC collaborated with the Bureau of Justice Statistics to create an interim, population-based formula to distribute the set-aside funds for FY 2020. OVC consulted with Tribes on the interim formula, and introduced the new noncompetitive, formula based, two-phase application process for the TVSSA that year. (See Appendix A for a flow chart of the formula allocation process.)

Under the new noncompetitive process in phase one, all eligible applicants were required to submit a declaration, referred to as a Population Certificate, noting the size of the population to be served with FY 2020 set-aside funds. OVC used the data in these declarations to distribute the set-aside funds among all eligible applicants via the interim population-based formula. OVC then

informed each phase one applicant about their formula allocation for FY 2020. In phase two, OVC invited these applicants to submit a full application, including a program narrative and budget, for their allocation amount. OVC created the flexibility for applicants to select an award period of 12–60 months.

Some applicants participated in phase one but not phase two, and some phase two applicants submitted applications that totaled less than their formula allocation amount. OVC ultimately made 133 awards, totaling \$112.6 million to eligible applicants under the FY 2020 TVSSA Program. OVC distributed the unclaimed set-aside funds to eligible tribal governments and tribal-serving organizations that submitted applications for funding to OVC's other FY 2020 discretionary grant programs. By this method, OVC ultimately committed all but \$9,244.00 of the total amount of Tribal Set-Aside Funding from the CVF in FY 2020.

FY 2021: TVSSA Formula Grant Program

Congress authorized a 5 percent Tribal Set-Aside from the CVF cap in FY 2021, resulting in a total set-aside of \$100.75 million. As in FY 2020, OVC invited all federally recognized tribes to apply for set-aside funding, regardless of whether they received funding in the past, and regardless of the unobligated (unexpended) balance or time remaining in the award period for their previous TVSSA awards. A streamlined, noncompetitive, formula based, two-phase application process was used. OVC made 142 TVSSA Formula Grant Program awards in FY 2021, totaling \$90,321,186. Set-aside funds not distributed through the formula process supported training and technical assistance projects to help Tribes implement their victim services projects, creation of a map of all available victim service projects, support for Victim Service Specialists to assist victims with federal cases, planning for the December 2022 Indian Nations Conference, and support for the Tribal Assistance Program to connect tribes to federal criminal justice databases. In FY 2021, OVC committed all but \$121 of the total amount of the Tribal Set-Aside funding from the CVF. Also in FY 2021, OVC began preparing an annual report on the expenditure of set-aside funds. FY 2022: TVSSA Formula Grant Program

Congress authorized a 5 percent Tribal Set-Aside from the CVF cap in FY 2022, resulting in a total set-aside of \$130 million. As in FY 2021, in FY 2022 OVC invited all federally recognized tribes to apply for TVSSA Formula Grant Program funding, regardless of whether they received funding in the past, and regardless of the unobligated (unexpended) balance or time remaining in the award period for their previous Tribal Set-Aside awards. The same formula allocation process was used as in the previous year.

In response to feedback from Tribes that the application process would benefit from being streamlined, OVC created new options for applicants to create the required project description in one of three formats: (1) as a traditional program narrative not to exceed 20 pages; (2) as a checklist using the format provided within the solicitation; or (3) via an interview with OVC staff, who then documented the information about the planned project into a checklist that the grantee would submit with their application.

OVC made 169 TVSSA formula awards in FY 2022, totaling \$116,260,509. Set-aside funds not

distributed through the formula process supported training and technical assistance projects to help Tribes implement their victim services projects, execute the December 2022 Indian Nations Conference, and support for the Tribal Assistance Program to connect Tribes to federal criminal justice databases. In FY 2022, OVC committed all but \$10,090 of the total amount of Tribal Set-Aside funding from the CVF. The Nisqually Tribe subsequently declined to accept their award of \$504,456. FY2023: TVSSA Formula Grant Program

Congress authorized a 5 percent Tribal Set-Aside from the CVF cap in FY 2023, resulting in a total set-aside of \$95 million. OVC allocated \$85.1 million for the TVSSA Formula Grant Program. The same two-phase application process was used as outlined in Appendix A. OVC streamlined phase one of the process for Tribes to submit Population Certifications by February 17, 2023, by creating an electronic form available on OVC's website.

In phase one of this application process, 267 eligible applicants signaled their intent to participate in the FY 2023 TVSSA formula grant program by submitting a Population Certification by the deadline. OVC applied a minimum award amount of \$251,383 to each applicant, and then applied the same population-based formula that was used in FY 2022 to allocate the FY 2023 available funds. (See Appendix B for a description of OVC's Tier Allocation structure.) On March 30, 2023, OVC notified the 267 eligible applicants who submitted Population Certifications informing them of their FY 2023 formula allocations and inviting them to submit a noncompetitive application into the Department's online JustGrants system no later than June 13, 2023, to receive their formula-allocated funds. (See Appendix C for list of all eligible applicants and FY 2023 allocation amounts.)

Applicants were again provided the option of completing their application program description in one of three formats: (1) as a traditional program narrative not to exceed 20 pages; (2) as a checklist using the format provided within the solicitation; or (3) via an interview with OVC staff who would document the information about the planned project into a checklist that the grantee would submit with their application. OVC staff, supported by technical assistance providers, conducted 65 virtual interviews with applicants using the required application Checklist. In addition, OVC implemented an Alaska Pilot Project under which four OVC staff traveled to multiple cities in Alaska to conduct in-person interviews with 25 applicants, who requested the option to develop the program narrative via an interview with OVC staff. A total of 90 virtual and in-person interviews were conducted by OVC staff, which was 30 percent more than in 2022.

In FY 2023, in response to feedback received during consultations and listening sessions that funds were needed for construction and renovation projects to support the delivery of victim services, OVC supported TVSSA applicants in including these projects in their project designs. In FY 2023 applicants requesting funds for renovation or construction activities, including the purchase, installation, and site preparation for modular buildings and other prefabricated structures, submitted a Construction-Renovation Questionnaire with their application. The purpose of the questionnaire was to assist applicants in articulating their plans for construction projects with the goal to expedite referrals for specialized technical assistance and the approval process to begin renovation or construction activities. OVC received new applications from 36 Tribes interested in using FY 2023 funding for construction or renovation projects.

OVC staff hosted four pre-application webinars and two days of “Office Hours” to provide guidance and technical assistance on the TVSSA application requirements and submission process. OVC posted the webinar recordings, presentation materials, and transcripts on its website. Because some applicants had difficulty submitting their applications by the deadline, OVC extended the deadline until June 16, 2023, and re-opened JustGrants to accept applications from Tribes who planned to apply. As a result, 212 applications were received in JustGrants, representing a 25 percent increase from the previous year. Twenty-three applications were received from first-time applicants for OVC grants. Ten of the new applicants were from Alaska.

In FY 2023, OVC made 212 TVSSA Formula awards, totaling \$69,632,900. (See Appendix D for the list of the FY 2023 TVSSA Formula Program Awards.) During the application process 55 Tribes either withdrew or did not complete the FY 2023 applications, and a few Tribes requested less funding than their formula allocation. Tribes expressed varied reasons for not applying for TVSSA funding. Some of the Tribes realized new funding was not needed to continue their victim service programs in FY 2024 and others opted to apply as a member of a Consortium. Some Tribes indicated turnover in staff or Tribal leadership, insufficient time to complete the application, or lack of communication or confusion about the application process as other reasons for not requesting an award.

In determining how to use the unclaimed formula funds from these 55 applicants, OVC conducted an analysis of data related to the TVSSA 799 awards made from FY 2018–FY 2022. OVC found that:

- Of the 322 grantees that received funding under TVSSA between FY 2018–FY 2022, 42.5 percent (137) had 3 or more active awards and approximately 20.8 percent (67) had 4 or more active awards with significant unobligated balances.
- Of the 799 awards made with TVSSA funding since FY 2018, 85.2 percent (681) of these awards had not reached their end date prior to September 30, 2023.
- Most grantees requested project period extensions up to 60 months to meet project goals and objectives and to expend unobligated funds to meet critical victim service needs. For example, for awards funded in FY 2019, 78 percent received project period extensions.
- Of awards made between FY 2020–FY 2022, 95 have not met the criteria for budget clearance, creating a hold on over \$57 million dollars in grant funds.
- Upon closeout of 118 awards funded between FY 2018–FY 2022, more than \$20 million was unobligated and returned to the Crime Victims Fund.
- Of awards made in FY 2022, five grantees have not officially accepted their award and one grantee declined their new award.

OVC did not re-run the formula allocation to redistribute unclaimed TVSSA funding because of the significant burden it places on Tribal grantees staff to revise their project designs and budgets for a minimal increase in award amounts. OVC allocated the remaining amount of the Tribal Set-Aside Funds, \$25,367,099, to support Tribal programs and activities as listed in Appendix E. OVC committed all but \$1.00 of the total amount of Tribal Set-Aside funding from the CVF in FY 2023.

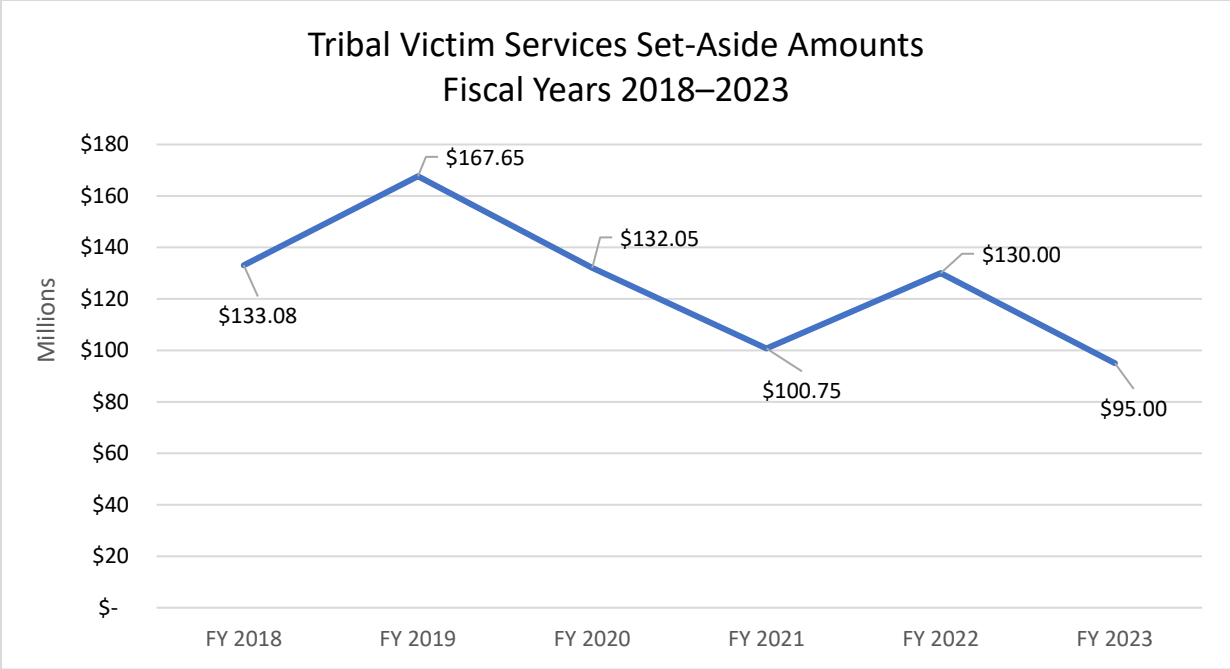
OVC's Modifications to the TVSSA Program in Response to Feedback from Tribes

OVC has made changes to the TVSSA program over the years in response to feedback from Tribal leaders received in Consultations, listening sessions, and Federal Advisory Committees. Here is a list of the key actions taken:

- Established a Tribal Division with staff dedicated to administering the TVSSA formula grant program, and other tribal grant programs. In FY 2024, Tribal Division staffing will grow by up to a third to better support Tribal grantees.
- Implemented a formula for disbursing Tribal Set-Aside funds, in response to past tribal consultations, Federal Advisory Committee hearings, and listening sessions, where Tribal leaders expressed a strong preference that the Tribal Set-Aside funding from the Crime Victims Fund be distributed using a formula, rather than as a competitive program. In FY 2023, OVC streamlined the population certification process by offering an electronic submission form and providing applicants with technical assistance.
- Offered TVSSA program applicants the flexibility to choose an award period between 12–60 months, an option that is unique among OVC's discretionary grant programs, and that is designed to address Tribal leaders' concerns that a 36-month award period did not adequately meet the needs of their communities.
- Simplified the TVSSA program application process by providing an electronic form to streamline the submission of the Population Certificate, eliminating the requirement for project abstracts, and offering tribal applicants the choice between developing a project narrative, completing a checklist, or participating in an interview with OVC staff to document their project plans. Further, OVC staff were available to conduct in-person interviews in Alaska and virtual interviews for lower 48 applicants.
- Clarified the allowability of certain expenses related to culturally specific victim services: consuming indigenous foods, and the ceremonial and communal preparation and sharing of food, which reinforces social and familial bonds, and preserves indigenous culture.
- Clarified how construction costs might be supported with TVSSA formula grants and providing technical support to grantees on these proposed projects, and provided technical assistance to support Tribes in implementing construction and renovation projects.
- Expanded the allowable uses of TVSSA grant funds to support victim services in Missing or Murdered Indigenous Person (MMIP) cases.

ANTICIPATING THE FY 2024 TRIBAL SET-ASIDE

OVC anticipates that Congress will again create a set-aside for Tribes from the FY 2024 CVF budget allocation. The House and Senate Marks suggest the set-aside may be significantly lower than the set-asides from previous years, which will impact the amount of funding available for TVSSA formula awards next year.



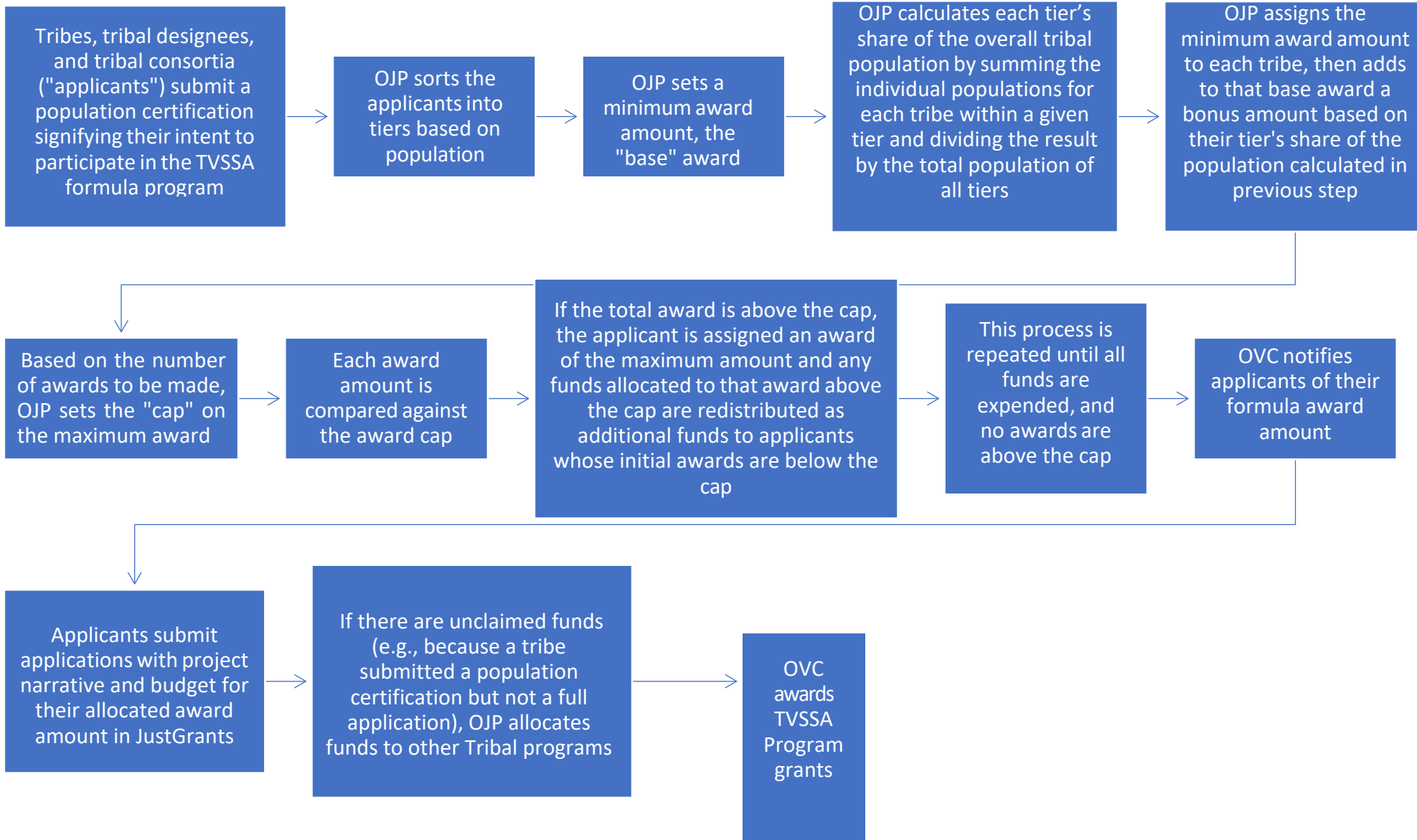
OVC is proposing to retain many of the TVSSA program features that have come to define the program including:

- Awarding TVSSA funds using a noncompetitive application process that allocates the funds based on the total number of applicants and the population to be served by each applicant’s proposed project.
- Using a two-phase process, which requires all interested and eligible applicants to submit a population certificate to signal their intent to participate in the program in winter 2024 and a program narrative or checklist (or interview with OVC in lieu of a narrative) and budget in spring or summer 2024.
- Allocating any unclaimed TVSSA funds to applicants who complete the application process, and/or to tribal applicants to other OVC Tribal programs so that the funds can serve Tribal communities.
- Consulting with Tribes in January, 2024 to receive suggestions for how to administer the TVSSA program to best support Tribes’ needs.
