#### Describe any planning or training events held during the reporting period.

Some of the training topics included: Surviving Secondary Trauma; Effective Strategies for Communicating with People who are Deaf or Hard of Hearing; Understanding Intimate Partner Violence; Sexual Assault Nurse Examiner; Cultural Implications in Trauma Informed Care. Planning events- The Bureau Chief attended bi-weekly calls with the DOJ/OVC Consultant to strategically plan for spending.

### Describe any program policies changed during the reporting period.

#### Describe any earned media coverage events/episodes during the reporting period.

An OAG press conference was held to educate the public on the Urban League Thrive Program. This project is VOCA funded.

#### Describe any coordinated responses/services for assisting crime victims during the reporting period.

Bureau staff continues to assist victims and families of the Marjory Stoneman Douglas High School shooting in Parkland, Florida. Through the Antiterrorism and Emergency Assistance Program grant, the OAG contracted with 3 organizations in Broward County to continue services for the community. In this reporting period, 7 Law Enforcement Line of Duty Deaths occurred, in separate incidents, involving the City of Miami Police Department, Hillsborough County Sheriff's Office, Pinellas County Sheriff's Office, Tampa Police Department, Orlando Police Department, Daytona Beach Police Department and the Nassau County Sheriff's Office. The Office of the Attorney General (OAG), regional Victim Services Program Specialists (VSPS) immediately reached out to the law enforcement agency affected and offered assistance. They then worked with the chain of command and the victim's family at each respective agency to guide and help with the Emergency Responder Death Benefit funded through the Victim Compensation Program. Florida also started it's first Trauma Recovery Center in Miami.

#### Please discuss the major issues in your state that either assist or prevent victims from receiving assistance during the reporting period.

Language barriers continued to be a challenge for many organizations in the South Florida area. In some remote areas of the state, there are few or no local agencies to assist victims who may have difficulty completing forms and filing applications for compensation. Affordable housing and transportation continue to be an issue for all crime victims. The COVID global pandemic continues to cause many challenges for victim service providers in Florida. Due to restrictions put in place to combat the pandemic, the hours of availability and critical staffing shortages, may have impacted providers ability to help victims in person. Some organizations continue to offer remote advocacy services however not all victims have access to the technology needed. The lack of volunteers also was a detriment to services.

# Please describe ways that your agency promoted the coordination of public and private efforts within the community to help crime victims during the reporting period.

The Office of the Attorney General (OAG) Victim Services Program Specialists (VSPS) continue to work with local organizations to assist crime victims and their families of the Marjory Stoneman Douglas High School shooting and other violent crimes. The Victim Services Program Specialists provide trainings on Victim Compensation Programs, Address Confidentiality Program to local service providers and other allied professionals to help identify victims and refer them to services. These trainings used to be in person, however they are now offered either in person or virtually. The Advocates participate in a wide range of community meetings like Victims Rights Coalitions, Human Trafficking Coalitions, Senior Services, and Fatality Review Teams for Domestic Violence, Elder Abuse, and Child Abuse. Several employees continue to participate in community exercises to prepare for mass disasters and participate on local mass casualty response groups. The Bureau Chief and Division Director continued to serve on Statewide work groups and meet with statewide stakeholders to coordinate services public and private efforts to assist crime victims.

#### Please describe any notable activities at the grantee level during the reporting period that improved delivery of victim services.

The OAG awarded funding to 20 new programs which included a Trauma Recovery Center and Urban League Thrive project. In addition to funding current subgrantees for an additional cycle, the OAG increased all current subgrantee awards through an amendment process after the start of the grant year. Additionally, the OAG provided an emergency increase to 36 subgrantees providing them with much needed funds to continue operations. The OAG also awarded funding to 20 new applicant agencies to provide services to crime victims. Also, the OAG completed funding of the Generator Project, providing Certified Domestic Violence Centers with generators to keep victims safe during power outages.

# Please discuss each priority (i.e., child abuse, domestic assault, sexual assault, and underserved) in which VOCA funds have been used to assist crime victims during the reporting period

Although many of the awarded agencies continued to provide services to victims of the priority categories, some agencies specialize in services to specific victims. For example, child protection teams and children's advocacy centers are awarded funds to provide services to victims of child abuse. The statewide projects that specialize in services for domestic violence victims continued to be funded at the local level and Domestic Violence Centers continued to receive funding for other projects. The Florida Council Against Sexual Violence continued to receive funding for victims of sexual assault along with the certified rape crisis centers. Funding for underserved victims of crime are awarded to agencies providing services to survivors of homicide, victims with disabilities, victims of elder abuse, victims of DUI/DWI and human trafficking victims. Project Cold Case, a unique VOCA subgrantee continued to receive funding to provide services to families of victims in unsolved homicide cases.

#### Please briefly describe efforts taken to serve Victims of Federal crime during the reporting period.

The OAG Regional Victim Services Program Specialists continue to work with the FBI Victim Advocate Units throughout the state. In addition, the Agency worked with the DOJ/OVC consultant to enhance victim services in Florida.

Please identify any emerging issues or notable trends affecting crime victim services in your state during the reporting period.

Language barriers continue to be a challenge. In the South Florida area many victims do not speak or read English. Numerous agencies do not have interpreters to assist non-English speaking crime victims. Undocumented victims fear deportation, having their children taken away or facing more violence from the perpetrator, if they report to law enforcement. In some remote areas of the state, there are few or no agencies to assist victims who may have difficulty completing and filing applications and required documentation. Due to COVID-19 many agencies provided services through technology, however, some victims may not have the internet access needed for these types of services and extreme staffing issues is also an emerging issue.

Please briefly outline any staffing retention issues that your victim assistance program has and why these issues may occur during the reporting period.

High turnover rate due to insufficient salary and extremely heavy workload.

### Please explain your state process to publicize its victim assistance funding for services to victims of crime during the reporting period.

Plan to Subgrant Funds. The priority 10% will be allocated and additional needed services for victim populations will be reviewed and awarded as appropriate. Additional needs for victim services are identified through meetings with stakeholders, including representatives from the Coalition Against Domestic Violence/Department of Children and Families, Florida Council Against Sexual Violence, the Department of Health, Children s Medical Services, the Florida Network of Children s Advocacy Centers and other professionals in the victim services field. In December of each year, the Office of the Attorney General distributes a Notice of Availability for the upcoming Fiscal Year funding to hundreds of agencies throughout the state notifying them of the opportunity to apply for VOCA funding in the following manner: Published in the Florida Administrative Weekly Posted on the OAG Website Distributed to hundreds of agencies throughout the state via mail Distributed to all registered users in the EGrants system Distributed at community coalition and task force meetings throughout the state by regional OAG Victim Advocacy staff Notification to statewide organizations by the Bureau Chief Discussion at workgroups and taskforces attended by the Division Director and the Bureau Chief The Division Director and the Bureau Chief reach out to the Coalition Against Domestic Violence/Department of Children and Families, the Florida Council Against Sexual Violence, Department of Health Children's Medical Services and The Florida Network of Children's Advocacy Centers, to discuss funding larger projects that would benefit victims on a statewide basis. Both the Division Director and the Bureau Chief attend meetings throughout the state, speak with interested agencies and serve on task forces and workgroups where they consistently educate statewide stakeholders about the availability of VOCA funding. In addition to the current subgrantees, the OAG funded 20 new service providers during this review period

Please explain how your program is able to respond to gaps in services during the reporting period.

OAG Regional Victim Services Program Specialists are well connected to the communities they serve throughout the state. They work with agencies to improve victim services at the local level. The OAG hired an employee to conduct outreach to work with service providers to determine gaps in services.

Please list and explain any outcome measure(s) that are reported to the governor, legislature, or other state entity during the reporting period.

The Division of victim Services publishes an annual report that is provided to the legislature and Governor.
