Our efforts have included, among others, the improvement and expansion of the services which are offered and are available to the victims by the Victims Assistance Grant Program. The Puerto Rico Department of Justice through the External Resources Division has funded 159 sub-grantees. Among these sub-grantees are private non-profit community bases programs, non-profit faith organizations, municipalities, and government agencies. As a Grantee, we encouraged sub-grantees to maintain coordination between public and private organizations so the services provided may be of the best quality and in accordance with state laws and regulations. The subgrantees have to submit with each proposal the Volunteer Services Certifications.

Please discuss the major issues in your state that either assist or prevent victims from receiving assistance during the reporting period.

One of the biggest issues faced in Puerto Rico is that due to our internal process, it takes a long time before we can pay compensation benefits to the victims. We are aware of this situation and are looking for alternatives to solve this problem. Due to the fact that the majority of victims are of scarce resources, we should act faster in order for them to receive their payment sooner. Another issue for these victims is that since most of them are from scarce resources they are not able to pay for all their needs, such as housing, and payments of water, light, and rent bills. The state fund of victim compensation does not cover these needs since the law does not provide for their reimbursement. Nevertheless, there are other programs that provide this kind of help, although resources in Government are scarce.

Please describe ways that your agency promoted the coordination of public and private efforts within the community to help crime victims during the reporting period.

Our efforts have included, among others, the improvement and expansion of the services which are offered and are available to the victims by the Victims Assistance Grant Program. The Puerto Rico Department of Justice through the External Resources Division has funded 159 sub-grantees. Among these sub-grantees are private non-profit community bases programs, non-profit faith organizations, municipalities, and government agencies. As a Grantee, we encouraged sub-grantees to maintain coordination between public and private organizations so the services provided may be of the best quality and in accordance with state laws and regulations. Please describe any notable activities at the grantee level during the reporting period that improved delivery of victim services.

Throughout the year we have provided technical assistance to the development of the sub-recipients. We also constantly monitor and evaluate the services offered by the sub recipients. This monitoring process includes two phase of the monitoring guide, wich covers the administrative, fiscal, programmatic, and closeout monitoring. Among many seminars, orientations and workshop our sub grantee have attended to improve the services to crime victims are: Psychological trauma of Crime victimization, crisis intervention, domestics violence and comprehensive intervention with children in dangerous situations. VOCA funds have expand the services during the new VOCA guideline, witch has been a big step to help to assist all of crime victims during the reporting period.

Please discuss each priority (i.e., child abuse, domestic assault, sexual assault, and underserved) in which VOCA funds have been used to assist crime victims during the reporting period

History Summary 46-year-old female, Puerto Rican, married, with two children. The firstborn was a female of 27 years old and the second child was a 17-year-old boy. Her health came in between her ability to work due to suffering four strokes during several years. These health problems caused different problems in her motor system. Summary of the Case: She started individual psychotherapy on November 9, 2017, at Centro Vida Plena, with social worker Luz Rivera after being referred by the Family Department. The services received were of help with parenting skills and parent workshops. These services were needed due to the problems with her son. He started using drugs and stealing, with these problems he invaded her house. He destroyed several premises inside the house and also attacked her. Due to this, he was entered into a correctional institution. After these problems, the Family Department decided to create a service plan for her and this was how she arrived at Centro Vida Plena. She seemed worried about the situation and wanted to find solutions to regain her relationship with her son. The woman received an initial interview, 10 individual psychotherapies, and eight parent workshops. The psychotherapies were carried out bi-weekly and her parent workshops were weekly. She took about 4 months of nonstop therapies showing her commitment to getting better and prepared herself to be able to help her son once he got out. 2 Case number 17-4489 She was discharged on March 20, 2018. When she was discharged she was stable and showing great success. She met all the goals that were stablished in her service plan. Achievements: She developed techniques in how to discipline teenagers and parenting skills. How to develop communication with her kids. She learned about the 246 law of child abuse. Worked on developing great self-esteem.

Please briefly describe efforts taken to serve Victims of Federal crime during the reporting period.

The Victims Witness Specialist of this office, Ms. Orlando Rios-Walker, maintains contact with this Program, the External Resources Division and he s invited to participate in our official activities. In addition, Mr. Rios Walker refers federal victims to VOCA Funded programs to receive counseling and therapy.

Please identify any emerging issues or notable trends affecting crime victim services in your state during the reporting period.

Puerto Rico has an increase in all crime categories between them are suicides, hate crimes, and gender violence. All of these issues emerge from natural phenomena (earthquakes and Pandemic) occurring during the beginning of the year 2020.

Please briefly outline any staffing retention issues that your victim assistance program has and why these issues may occur during the reporting period.

Cost of living and minimum salaries wage are not among the real economy of the island. States governments, Non-Profit Organizations, and Municipalities are confronting problems to retain staffing.

Please explain your state process to publicize its victim assistance funding for services to victims of crime during the reporting period.

Puerto Rico Department of Justice has implemented the method of publishing information about VOCA funds. The funds are announced on the web pages of the Department of Justice for all Non-Profit Organizations, public agencies, Universities, and Municipalities.

Please explain how your state is able to direct funding to new/underserved populations during the reporting period.

During the reporting period, the state made a public announcement to promote VOCA funds, on special to serve underserved victims populations.

Please explain how your program is able to respond to gaps in services during the reporting period.

The VOCA Program to address service responses has requested as public notice to develop projects in a few served areas (Center part of the island) to offer direct services. An example of this direct services projects that provide for women victims of domestic violence and sexual abuse in the center and west part of the Island are CAPROMUNI Mayaguez and Portal de Amor in San German.
