The only issue we confronted this past year is that the staff is now working remotely due to Covid restrictions. There were some technical issues from late March through April, but they were addressed by the in-house and state IT department. New Jersey is fully capable and budgeted to fully meet its needs.

The agency s Intake Unit works closely with the FBI and Federal victim advocates to serve federal crime victims. The Agency s staff also are members of the Human Trafficking Task Force which allow collation with Federal and State agencies.

The VCCO Public Outreach Committee is structured to inform our stakeholders and supporters about training opportunities, resources and materials to both public and private organizations, first responders, non-profits, prosecutorial staff, faith-based communities and constitutes. The VCCO sponsors annual events and campaigns; such as, Crime Victim's Right's Week held every April, Domestic Violence Month, held every October, Bullying, Sexual Awareness and other related violence related monthly topics in our continuous efforts to promote awareness and meet the needs of communities. In partnership with The Office of The Attorney General, the Agency's sponsor events are publicized and published via media outlets and our website. All events were canceled since March, 2020 due to Covid restrictions. In the final months of Fiscal year 2020 a limited number of virtual training sessions took place.
