1. Please explain any significant change in the number of applications received during the reporting period.

During this reporting period, the number of applications stayed relatively the same as the previous reporting period.

2. The average length of time to process an application for claim eligibility for compensation

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. Due to the COVID-19 pandemic, staff worked remotely during this reporting period. This did not cause any significant change to the application process, though correspondence was done electronically when possible. Applicants submit their claims by email, fax or regular mail. Starting in July 2021, victim's could submit an application through the new Victims Service Portal. Claim information is entered into the ClaimsAssistant system and the claim is assigned to a specialist. A form is then sent to the investigating law enforcement agency to verify the crime. Claims specialists review the application and the law enforcement form to make an initial eligibility decision. If all of the eligibility requirements are met, the file is forwarded to other staff to gather billing forms from providers listed on the application, an employment form, funeral billing form, and other documentation of losses listed on the application. The claims specialists then review all of the information received, and determine the amounts to be paid to the applicant and/or the providers. Another staff person prepares a payment order, and explanation of benefits forms to send to the applicant and providers. If the claim clearly does not meet eligibility requirements or there are no expenses to pay, the staff deny or close the claim. If there is some question about the applicant's eligibility under the program's statutes and rules regarding certain requirements, the claim may be forwarded to the 5-member Reparations Board for review. The board votes on the eligibility of claims forwarded to them by staff, and they may vote to pay in full, reduce the claim, or deny the claim. There is an appeals process for applicants who are dissatisfied with a staff or Board decision on a claim.

- Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.

During this reporting period staff primarily teleworked due to the COVID-19 pandemic. In addition, a new claims processing system was installed in late June 2021. Both of these resulted in a slight increase in processing time.

5. Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.

The program continued working closely with the FBI s victim specialists in Minneapolis and Bemidji to serve victims of federal crimes during this reporting period. Reparations staff responded to questions from FBI specialists about reparations policies and procedures. This collaborative effort helped ensure the best services for victims of federal crimes.

6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

A new claims processing system was developed and installed. The system enables victims to submit applications through an on-line portal and will allow the program to move towards a paperless process.

Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

The VOCA administrative funds are dedicated to the support of one clerical position with the reparations program. The person in this position sets up new reparations claims, answers phone inquiries from applicants and service providers, sends an initial letter to the applicant, and corresponds and obtains law enforcement reports from the investigating law enforcement agency. This position helps the program process claims in a timely manner.

8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

There were no new laws, initiatives or policy changes regarding victim compensation during this reporting period.

System-coordination efforts included participating in a virtual training that was attended by advocates and criminal justice professionals from around the state. The trainings included information on reparations eligibility requirements, covered expenses including Native American healing ceremonies, the application process and how to appeal a claim decision. Additional reparations trainings were provided at other venues as well, including the Minnesota Victim Assistance Academy.

As part of the reparations awareness campaign to reach Native American communities, PSAs aired in tribal communities.
