NARRATIVE QUESTIONS

1. Please explain any significant change in the number of applications received during the reporting period.

There were 5,317 Crime Victims Compensation Act (CVCA) applications filed in this fiscal year and 3,322 filed in last fiscal year. On July 4, 2022, a mass casualty event occurred at a parade in Highland Park, IL. There have been over 1,000 applications filed as a result of this event substantially increasing the number of CVCA claims filed.

2. The average length of time to process an application for claim eligibility for compensation

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. Applications are mailed to the Illinois Attorney General then filed with the Illinois Court of Claims. The Illinois Attorney General assigns the claim to a Claims Analyst who conducts an investigation to determine whether the application meets the eligibility requirements of the Crime Victims Compensation Act 740 ILCS 45/1 et seq. The Illinois Attorney General then prepares a Determination Letter indicating whether the claim is an award, an award no pay or is a denial. All eligible expenses are verified prior to a determination. The Court of Claims reviews the proposed Determination Letters to insure it meets legal and fiscal requirements. The Determination Letter is mailed to the Claimant by the Illinois Attorney General. The Claimant has 30 days thereafter to appeal the decision contained in the Determination Letter. If a Claimant appeals from a decision in a Determination Letter, the case is set for hearing with a Court of Claims Commissioner who then submits a recommendation to the Judge assigned to the case. The assigned Judge reviews court transcripts, caselaw, statutory law, the Commissioner's recommendation and other appliable evidence prior to entering an Order on the Appeal.

4. Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.

5. Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.

Federal crime victims are served the same as all other Illinois crime victims with timeliness, accuracy, consistency and service with the professional cooperation and assistance of our local FBI Victim Assistance Coordinator.

6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

Pursuant to legislative amendments, the claims process was modified to decrease the claim processing time. This resulted in a cooperative Memorandum of Understanding (MOU) between the Illinois Attorney General and the Court of Claims to improve the efficiency of the claims process.

Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

The administrative fund provides for the salary of a Commissioner in Chicago who is solely dedicated to holding prompt hearings for the victims of violent crime. VOCA administrative funds assist vital staff to attend national training so the program can stay current on the national trends in providing services to victims of violent crimes. This year's national conference was modified to virtual so administrative funds were budgeted but not utilized for the training in this federal fiscal year.

8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

The Illinois Crime Victims Compensation Act (CVCA), 740 ILCS 45/1 et seq., was amended effective January 1, 2022. The following are some of the highlights of the amendments. The Illinois Attorney General will make initial claim determinations whereas the Illinois Court of Claims will handle fiscal and appeal matters for the CVCA program. The maximum for funeral and burial expenses increased from \$7,500 to \$10,000. The maximum for loss of wages and loss of support increased from \$1,250 per month to \$2,400 per month. For all crimes occurring on or after August 7, 2022, the maximum benefit increased from \$27,000 to \$45,000. The time limit to file a claim has increased from two years to five years. This will result in more claims being filed with increased benefits to the innocent victims of violent crimes in the State of Illinois.
