Staff have maintained a hybrid work schedule for the past year. Policies and procedures are continually reviewed to ensure workflow continues and the program continues to provide a high level of service to crime victims.

CVAD maintains working relationships with victim/witness coordinators in both the Northern and Southern Districts of Iowa, as well as with the FBI victim specialist for the state. When there is a victim of a federal crime, CVAD relies upon those connections to ensure that compensation program information is available to victims. Compensation staff also maintains regular contact with these individuals when obtaining an application from victims of federal crimes.

lowa VOCA Assistance grant funds are administered from the same office as lowa's Victim Compensation program. This allows for significant coordination among staff in both programs. We conduct frequent trainings with partners in law enforcement and prosecution at the local, state and federal levels to ensure victims know of the compensation program. Our statewide DV and SA coalitions provide training to new advocates working in programs funded by the VOCA Assistance grants, which includes information on the compensation program and its available benefits. All CVAD staff has the opportunity to participate in these trainings.

10. Please explain any public outreach efforts to improve awareness of your program.

CVAD staff, led by its Training/Advocacy/Outreach team, engages in training and outreach efforts across the state. In addition to exhibitor tabling at a variety of conferences and events, CVAD also hosts its own training and/or informational sessions, in person and virtually. Audiences include law enforcement (including new cadets), victim services programs and advocates, prosecutors and victim/witness coordinators, medical personnel and SANEs, social workers and child protection workers, and mental health providers.
