NARRATIVE QUESTIONS

1. Please explain any significant change in the number of applications received during the reporting period.

The NH Victims Compensation program has noted a significant increase in the number of applications received during the reporting period. A 52% increase in the number of applications received from reporting period July 1, 2022 to September 30, 2022 compared to the same period in 2021. NH has also seen a 40% increase in the number of application from the current reporting period compared to the last reporting period of April 1, 2022 to June 30, 2022.

2. The average length of time to process an application for claim eligibility for compensation

Count days from time of receipt of application to decision. 57

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. NH Victims Compensation Program receives applications for crime-related assistance directly from a victim, an advocate or health care professional working with a victim. Applications are processed and opened within 1-2 business days upon receipt. The program staff forwards an acknowledgment letter to the claimant, which contains the claimant s claim number and requests supporting documentation, when applicable, and provides the claimant with information concerning debt collection delay for crime-related expenses. Staff requests police reports and completion of a Law Enforcement Authority Verification Form from the law enforcement agency investigating the crime or a letter of support from a victim advocate, if the victim did not report to law enforcement. Upon receipt of the police reports or letter of support, the claim is marked as commission ready and the program coordinator reviews each claim for eligibility and makes a recommendation in accordance with New Hampshire law and Administrative Rule. The coordinator submits the reviewed claims to the New Hampshire Victims Compensation Commission for review and decision. The Commission meets once a month, in a non-public session and reviews, discusses and votes on each commission ready claim to award, reduce, deny or table. Immediately following the Commission meeting, program staff contact the claimants in writing concerning the Commission s decision. Claims that are awarded are provided with an explanation of benefits form. Claims that are denied, are provided with information on how to appeal the denial.

The New Hampshire Victims Compensation Program has encountered no emerging/major issues or notable trends that affects this program s ability to meet the needs of crime victims during the reporting period.

The New Hampshire Victims Compensation Program has an excellent working relationship with the Victim/Witness Advocate at the N.H. U.S. Attorney s Office. Moreover, the program works well with the local FBI pertaining to victims of federal crimes. The program has not encountered any issues obtaining records to verify a crime-related injuries for victims of federal crimes.

Please describe any notable activities during the reporting period that improved the process of victim compensation services.

The New Hampshire Victims Compensation Program started the process to update our database to a cloud based system during this past reporting period. The system will improve the process of victim compensation services by, among other things, allowing providers and victims to check the status of their claim or payments via a secure remote access.

Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

No VOCA Compensation Administrative fund were used during this reporting period.

8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

The NH Victims Compensation Program has two statutory changes during this reporting period. New Hampshire House Bill 576, effective on July 19, 2022, codifies current best practices already in place by the Victims Compensation Program. This law ensures that child victims of sexual assault and human trafficking qualify to receive compensation and eliminates the deadline for child victims to come forward to file a claim. New House Bill 1235, effective on July 19, 2022, increases the amount a victim can receive under the Victims Compensation program to \$50,000, an additional \$10,000 more than what was allowable under the current law.

Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.

The NH Victims' Compensation Program's continued outreach provides system-coordination with various stakeholders and opens barriers for victims who may have not otherwise applied for services. Over the past reporting period, the coordinator New Hampshire Victims Compensation Program has attended various meetings via WebEx and Zoom and provided information on how agencies can work together to provide services to crime victims. Meetings where held with the Sexual Assault Nurse Examiners Board, the NH Attorney General s Trask Force on Child Abuse and Neglect and the State Victims Assistance Statewide Steering Committee to discuss how this program assists victims of crime. The Coordinator is also a member of the Attorney General s Task Force on Child Abuse, the Child Fatality Review Committee, Domestic Violence Fatality Review Committee and the Sexual Assault Nurse Examiners Board, where she provides insight and information concerning the Victims Compensation Program.

10. Please explain any public outreach efforts to improve awareness of your program.

Outreach and training is a priority of the New Hampshire Victims Compensation Program. During this reporting period, the program coordinator met with the New Hampshire Association of Chiefs of Police, Child Advocacy Centers, crisis center and system based advocates. Development is under way for quarterly virtual meetings to address compensation concerns or questions with law enforcement, advocates and health care service providers. New information forms are in the process of being created to assist with the application and eligibility process for survivors and those who work with them.

The NH Victims Compensation Program provides quarterly reports to the NH governor. The reports consist of the number of application received, claims approved and denied. It also contains the top five payments by service type and the number and amount paid for forensic sexual assault exams. NH RSA 21-M:8-g requires an annual report form the NH Victim Assistance Commission. The report was filed with the NH House Ways and Means Committee, the NH Senate Ways and Means Committee, the NH House Criminal Justice and Public Safety Committee and the NH Senate Judiciary Committee on September 15, 2022. The data will be reported separately in our progress report.
