## NARRATIVE QUESTIONS

1. **Please explain any significant change in the number of applications received during the reporting period.**  
Application increased by 9.5% from previous FFY. Ohio SB36 went into effect 3-1-22 which eliminated previous disqualifications. The number of applications increase by 386 during the last three quarters.
2. **The average length of time to process an application for claim eligibility for compensation**  
Count days from time of receipt of application to decision. 110  
  
Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. Claimants may file applications for crime victim compensation online or on paper with the Ohio Attorney General's Office. Claims examiners in the Crime Victim Services Section receive new applications on a daily basis and assign each a claim number. The following procedure is used to process each claim: 1) An economic loss investigator and field investigator are assigned to simultaneously investigate the claim. 2) The claims examiner and economic loss investigator send correspondence to the applicant and service providers requesting information needed to verify the applicant's expenses and calculate economic loss. This includes documentation of expenses incurred and documentation of collateral source benefits such as insurance. 3) Field investigators send requests to law enforcement for documentation needed to determine eligibility for compensation. This includes the police report, the coroner's report if applicable and suspect information. They also check with prosecutors to verify evidence held, court dates, and any restitution ordered and paid by the offender. 4) The economic loss and field investigators have 120 days from receipt of the application to complete their investigations. Investigators follow up by telephone and through correspondence to obtain all of the needed documentation. The processing time can be extended if necessary, but the office goal is to complete review of the claim prior to the 120-day deadline whenever possible. 5) An economic loss supervisor checks all claims whether a zero claim or an award claim. They make sure the expense calculations are accurate and detailed. 6) An Assistant Attorney General reviews the information gathered by the investigators and issues a Finding of Fact and Decision of the Attorney General regarding whether the applicant is eligible for an award. 7) If the applicant disagrees with the Finding of Fact and Decision, the applicant may request reconsideration within 30 days. A different Assistant Attorney General will then re-assess the initial determination and issue a Final Decision within 60 days. 8) The Final Decision of the Attorney General's Office may be further appealed to the Ohio Court of Claims. A decision by a judge of the Court of Claims is final.

4. **Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.**  
None. Mass casualty claims increased 110% but only represents 2.1% of all claims.
5. **Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.**  
The section works with advocates from the U.S. Attorney's office to assist victims with filing applications for compensation.
6. **Please describe any notable activities during the reporting period that improved the process of victim compensation services.**  
During this reporting period a major legislative change (SB36) expanded access to the Crime Victim Compensation program by removing criminal history and drug possession as mandatory disqualifiers. The Attorney General's Office has also continued utilizing the new Matrix claims management system to more efficiently process claims and communicate with victims. Victims can receive messages from Attorney General staff and submit their response directly through the secure website, which has reduced much of the need for paper correspondence. Although the exact impact of the expanded eligibility is not yet fully known, the updated technology will help the Attorney General staff to handle any increase in claims volume.
7. **Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.**  
No administrative funds are used from the grants. All grant funds are used to pay claims.
8. **Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.**  
The Ohio Legislature passed Senate Bill 36 which did the following: 1) Removed criminal backgrounds as eligibility disqualifiers 2) Removed possession of felony drugs as a disqualifier 3) Removed contributory misconduct as a disqualifier in homicide claims 4) Changed the statute of limitations to 3 years from the date of the incident for adults. Victims under 21 at the time of the crime have until their 24th birthday to file. 5) Created 2 new types of victims: close family members who observed the crime and parents of minor sexual assault victims.
9. **Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.**



Each year our office holds meetings, trainings and conferences to help victim advocates and law enforcement agencies. One Finding the Words training was held during this reporting period on 10-6 thru 10-10-2021 with 30 participants attending each course. Due to effect of COVID 19 pandemic, the training was held virtually. This is an intensive five-day forensic interviewing course using practice guidelines from the American Professional Society on the Abuse of Children (APSAC) and Office of Juvenile Justice and Delinquency Prevention (OJJDP) outlined in the bulletin. Two Days In May Conference on Victim Assistance was held May 9-10, 2022: this was the first in-person conference since the start of the COVID 19 pandemic. This 30th edition of the conference, organized around the theme A Celebration of Resiliency, was attended by 867 individuals and covered a wide range of topics including collaborative community responses, survivor agency within the legal system, and fostering victim resiliency through ethical storytelling. Awards were presented to individuals and organizations in recognition of their exemplary work to address the needs of victims. Ohio is one of four demonstration sites in the United States that received the Linking Systems of Care funding from the US Department of Justice-Office of Victims of Crime (OVC). OVC wishes to facilitate and improve efforts to bring healthcare, child welfare, justice, and other systems together, and to coordinate and align these efforts to ensure a timely and seamless response to young victims, their families, and caregivers, no matter the system of entry. The goal of the Linking Systems of Care for Ohio's Children and Youth project is to improve responses to child and youth victims and their families by providing consistent, coordinated responses that address the full presenting issues and full range of victims needs. Throughout the reporting period, we continued to see the impacts of COVID-19 on providers, and as a result had to re-work plans accordingly. This related relay is responsible for a request to continue our work, past the original due date. During this reporting period, the following items were accomplished: 1) Multiple significant content pieces, including the access paper and secondary traumatic stress toolkit, were drafted in their entirety and began the review process 2) Significant progress has been made with the structure of the expert witness training process, which is being developed in a way that will allow it to be adapted to other victim populations and to continue long after the project concludes. 3) Ohioheals.org was launched. The site includes information for victims and professionals with the goal of providing Ohio's youth with resources to better serve this vulnerable group. Ohio Domestic Violence Network purchased the domain and maintain the site. Additionally, the content was approved by OVC 4) The Project Team secured opportunities to train on the project at Two Days in May Conference on Victim Assistance (May 2022), the Ohio CASA Conference (September 2022) and the Supreme Court Annual GAL Symposium. 5) Case Western Reserve University (CWRU) ended role on grant as of 9/30/2022. CWRU developed paper addressing trauma responsive workplace culture and conducted literature review of published articles regarding trauma informed interventions.

10. **Please explain any public outreach efforts to improve awareness of your program.**

The Attorney General's Office has continued making public outreach a priority for the Crime Victim Compensation program. During this reporting period the office has focused on making our partner agencies aware of important statute changes that make more victims eligible for compensation. During spring and summer of 2022, the office conducted a series of regional presentations to provide consistent, updated information to our grant sub-recipients. In addition to the regional training, the office also participated in regularly-scheduled outreach with our partner agencies, such as the Ohio Domestic Violence Network's Domestic Violence Advocacy Fundamental course.

Ohio Revised Code (ORC) Section 2743.69 requires Ohio Attorney General's Office to provide an annual update on the Ohio Victims of Crime Compensation Fund under sections 2743.51 to 2743.72 to the Governor, the President of the Senate, the Speaker of the House of Representatives, and the minority leaders of both houses.

12. **Please provide any additional comments that are helpful to improving the Victim Compensation state and/or federal program.**

Continue to perfect the new portal system in the Matrix claims management system making it easier for victims to update their claims, and check the status of the claims from the onset to the decisions. Continue to review more claims that were previously awarded for subrogation purposes which will increase our subrogation revenue. Many former claims had no conviction information at the time of awards, and now we are able to follow up with the prosecution and conviction of the offenders and seek subrogation. Legislative changes to eliminate public record requests for all crime victim claims, thus protecting all victim and claimant's personal information from the offender or other predators. Legislative changes or federal grants issued specifically for relocation fees for domestic violence victims and all victims who need to relocate immediately to be safe from offenders. Legislative changes that will make money available in an emergency basis to help families bury their love ones when funeral directors require money upfront and there are no other funds for the family to pay. Victims can request publication from our office on line. Publications includes: Crime Victim Rights Booklet, Crime Can be Costly palm cards (also in Spanish), VINE brochures, Applications and Resource Guides. We also provide translation of 20 different languages thru Language Line Services.
