Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. A member of the intake team receives the application, supporting documentation, and photo identification. If the application is submitted in-person, the intake team shall make a copy of the application, police report, any other relevant documents, and claimants/victims photo identification, time stamp the application and scan it to the respective intake team member's work email address. Team member then emails all documents to CVCPApplications@dcsc.gov. If the application and supporting documents are submitted by fax (which automatically converts to an email), the intake team shall forward the documents to CVCPApplications@dcsc.gov. Some applications are submitted directly to CVCPApplication@dcsc.gov. All applications regardless of how received are forwarded to CVCPApplications@dcsc.gov, so that all applications are in a central location. The moderator monitors the CVCPApplications@dcsc.gov inbox and reviews the applications to ensure all the application pages have been submitted. If the application is complete, the moderator forwards the application and its attachments to one of the members of the intake team. The intake team member creates an electronic file in the name of the claimant/victim and places the documents in the electronic folder. o A photo ID is required to be submitted with all applications. If the claimant does not have a photo identification, the claimant/victim has an option to submit an identity declaration form with a photo of themselves or go to the main CVCP office or SE Satellite Office and have their photo taken by a member of the intake team. The intake team attempts to obtain signatures of the claimant/victim on all applications. Upon completion of application intake, the CE assigned with performing the quality review (QA) for the day, reviews the applications and documents in the electronic folders that have been created by the intake team. The QA completes the QA checklist and signs off as evidence of proper review and completion of the application information. After a CE verifies that the application has been reviewed by the completion of the QA checklist, the Moderator is informed of the status of the application via email. The Moderator uploads the accepted applications and all related documentation into CAS including the QA checklist, assigns a claim number, and assigns the claim to a CE within three (3) business days of receipt. Rejected applications must be uploaded to CAS as well. However, only the NOD shall be uploaded in these files. Rejected applications receive a claim number but do not get assigned to a CE. Rejected applications must be uploaded into CAS within three (3) business days. Any documentation that provides the basis for eligibility and/or compensation must be scanned into CAS within three (3) days of acceptance or rejection, including the following documents. Within five (7) business days of the Moderator assigning a new claim to the CE, the CE emails or sends via U.S. mail the claimant/victim a New Claim Letter indicating that their application has been received and will specify which documents are needed to complete their request for compensation. A signed copy of the letter is uploaded to CAS. The CE should attempt to contact the claimant/victim via telephone to have a conversation to verify the claimant's/victims requests and needs before sending the New Claim Letter. After the Claims Examiner (CE) completes review of the application, determines any eligible benefits to be paid, and reviews the evidence, the CE will request for the payment of bills from the CVCP Accounting Officer (AO). If the claim has been determined eligible and a bill or invoice has been received in the mail or email, then the assigned Assistant Claims Examiner (ACE) will forward the bill, invoice, or receipt to the appropriate CE. The CE will review and upload the document to CAS. The CVCP Accounting Officer (CVCP AO) saves a batch of approved payments in the shared drive for the Financial Operations Branch Accounting Technician (FOB AT) to retrieve daily. The batch export is generated in CAS by the CVCP AO and includes the name, address, and amount for each bill payment request. For each batch export from CAS, the CVCP AO uploads the accompanying invoice file, vendor file, and supporting documentation to the shared drive for the FOB AT to utilize in reviewing payment requests.
