Interim Decision is mailed to the Claimant. 6) The Claimant has fifteen (15) days to Appeal an Interim Decision to the Board. Appealed Interim Decisions result in Hearings. The result of any Hearing may be to Affirm, Modify, or Reverse the Interim Decision. 7) After the fifteen days has elapsed the Interim Decision is forwarded to the Executive Director/Designee to be reviewed a signed resulting in a Final Decision.

Currently, the program has three advocates dedicated to coordinating and participating in outreach events throughout the state, but particularly in underserved/underrepresented communities. In addition, the agency's Communications Director utilizes social media platforms to spread awareness about the program. Finally, Victims Compensation 101 trainings are held throughout the year and open to all professionals (e.g., law enforcement, advocates, providers) who come into contact with crime victims. The trainings are held to inform local partners about the Program and have them serve as a liaison/connector for potentially eligible claimants.
