## NARRATIVE QUESTIONS

1. **Please explain any significant change in the number of applications received during the reporting period.**

For the period of 07/01/2023 through 09/30/2023, the Office of Claims and Appeals (OCA) has experienced a slight decrease in the number of applications received as compared to the same period last calendar year. For the period of 07/01/2023 through 09/30/2023, OCA received 82 crime victims compensation applications compared to 89 for the same period last calendar year. This represents an approximate 7.8% decrease.

2. **The average length of time to process an application for claim eligibility for compensation**

Please explain your state's procedure for processing an application for claim eligibility, from time of receipt of application to decision. OCA has been experiencing an increase in claims processing time for crime victims compensation claims that is attributable to low staffing levels as compared to the number of applications received. For the period of 07/01/2023 through 09/30/2023, the average processing time for compensation claims was approximately 187 days. Compared to the same period last calendar year, claims processing times have increased by approximately 23 days, or approximately 14%. Upon receipt of a filed claim, the Executive Staff Advisor/Clerk enters the claim into the CVCB's electronic database, generates initiating correspondence to the Claimant, the prosecution if applicable, and to the Claimant's private attorney if applicable. The Clerk then forwards the case file to the investigator. The investigator conducts their investigation into the filed claim, which includes but is not limited to: conversations with law enforcement officials about the circumstances of the crime (individuals involved, relationships amongst involved parties, whether any conduct was exhibited by the survivor to indicate culpability in their injuries or death, etc.); verification on legal obligation of expenses submitted for compensation, outstanding balances, and payments made by survivors and insurance carriers; and obtaining missing information so as to allow the Board to have sufficient information upon which to base an award or denial. The investigator then drafts their investigative report, has the report viewed by the staff attorney, and then submits the full file to the Executive Staff Advisor/Clerk upon assent by the staff attorney. After receiving the complete file from the investigator, the Executive Staff Advisor/Clerk drafts a draft recommended order and after drafting assigns each case to one of the CVCB's three board members. The board member reviews the investigator's report and the draft recommended order prepared by the Executive Staff Advisor/Clerk and indicates their recommendation to the Executive Staff Advisor/Clerk. If the draft order is satisfactory, no edits are made. If the board member's recommendation differs from the draft recommended order, the Executive Staff Advisor/Clerk will edit the draft order to accurately reflect the board member's desire before serving on the claimant, the prosecution if applicable, and the claimant's private attorney if applicable. The claimant is afforded fifteen days to register disagreement with the recommended order in the form of an interagency appeal or exceptions. Once the recommended order has been served, the Executive Staff Advisor/Clerk places each claim on the Board's next available agenda for adjudication. Two weeks prior to the Board's meeting, the Executive Staff Advisor/Clerk submits the complete docket to the full Board, which includes each board member's vote indication, each served Recommended Order, and each investigative report. The full CVCB then meets at its regularly scheduled or specially called meeting to adjudicate all claims on its docket. Once adjudicated, the Executive Staff Advisor/Clerk drafts the CVCB's final orders for all claims on the docket and serves them on all appropriate parties. In the event that a claim is awarded, the Executive Staff Advisor/Clerk submits payment requests to the PPC's Office of Administrative Services (OAS) for processing through the Commonwealth's accounting system and mails checks upon receipt from OAS after processing.

4. **Please describe any emerging/major issues or notable trends that were encountered in your state that had an impact on your program's ability to meet the needs of crime victims during the reporting period.**

Over the past reporting period, claims processing times have increased for crime victims compensation claims. This increase is directly attributable to the increase in claim filings combined with low staff levels. This increase in processing time is hampering survivors ability to receive compensation from our program. Steps are being taken to counter this trend, including the hiring of a victim advocate, and working with the legislature to secure more funding for the program.

5. **Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.**

No additional steps were taken during the reporting period to serve victims of federal crime because strong relationships already exist between the Kentucky CVCB and both districts of the U.S. Attorney's Office along with the Federal Bureau of Investigation's Louisville branch. When a potential claim arises, representatives from both districts of the U.S. Attorney's Office and the FBI's Louisville branch will reach out to the Clerk and discuss the circumstances of the crime to determine if the CVCB may be able to provide compensation to the victim.

6. **Please describe any notable activities during the reporting period that improved the process of victim compensation services.**

The CVCB's Executive Director, Staff Attorney, Executive Staff Advisor, and Sexual Assault Examination Program Coordinator have been taking part in a working group headed by Senator Denise Harper-Angel of the Kentucky Senate to explore potential changes to CVC statutory and regulatory provisions. The Executive Director and Executive Staff Advisor have also testified before the Kentucky General Assembly's Interim Joint Committee on the Judiciary to provide an update on the CVC and SAE programs and detail the impact of recent legislative change on the CVC program.



7. **Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.**

Not Applicable. OCA does not use VOCA Administrative funds. All received VOCA funds are directed to victim compensation payments.

8. **Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.**

Over the last reporting period, there have been some notable activities that have improved the process of victim compensation services. The legislature passed Senate Bill 282 during its 2023 session, which increased award caps on crime victims compensation claims and expanded situations in which compensation could be awarded to a survivor. The overall award cap increased from \$25,000.00 to \$30,000.00 (or 20%). The cap on funeral/burial expenses increased from \$5,000.00 to \$7,500.00 (or 50%). The cap on lost earnings and loss of financial support increased from \$150.00 per week to \$300.00 per week (or 100%). These increases were long overdue. The cap for lost earnings and loss of support had not been increased since the founding of the program in 1976. All other caps had been increased more recently but had not been increased further over the last couple of decades. Senate Bill 282 also amended the CVCB's statutory language to allow for compensation for motor vehicle accidents in situations where the victim is injured and the perpetrator flees the scene and fails to disclose their identity (hit and run). Additionally, the CVCB issued a policy clarification that further increases compensation to survivors. Effective February 14, 2023, the CVCB can grant compensation to survivors for emotional support animals that are deemed necessary as a direct result of the crime. The policy capped the award amount at \$1,000.00, limits the eligible animals to cats or dogs only, and limits the award to the purchase or adoption of the animal, initial vaccinations, and spaying or neutering. Further, it clarified its ability to grant lost wages in the form of bereavement leave for up to four weeks to close surviving family members of homicide victims without requiring a physician or mental health counselor statement.

9. **Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.**

The Executive Staff Advisor sits on several committees that seek to improve access to victims services and ensure that survivors needs are being met: the Sexual Assault Response Team's Advisory Committee, the Sexual Assault Kit Initiative Task Force, the Violence Against Women Act's Services, Training, Officers, Prosecutors (STOP) Grant Implementation Committee, and the Steering Committee for the Kentucky Victims Assistance Academy. Likewise, agency staff present to a wide swathe of law enforcement and prosecutorial agencies regarding the programs available benefits, eligibility requirements, and processes.

10. **Please explain any public outreach efforts to improve awareness of your program.**

OCA staff continue to conduct monthly trainings on the crime victims compensation program with prosecutors, victim advocates (both systems-based and community-based), and allied professionals that interact with survivors. The number of professionals that have received training on crime victims compensation has continued to markedly increase. For the period of 07/01/2021 through 09/30/2021, a total of 20 individuals received training. This increased to 32 for the period of 07/01/2022 through 09/30/2022 and to 57 for the period of 07/01/2023 through 09/30/2023. This represents an increase of approximately 185% from Q4 2021 through Q4 2023.

11. **Please list any other outcome measure(s) that are reported to the governor, legislature, or other state entity that have not been reported in this submission. Provide the actual measure(s). The data may be reported separately in your progress report.**

The Kentucky CVCB does not regularly report program outcome measures to the governor, legislature, or other state entities. Pursuant to KRS 49.300(8), by January 1 of each year, CVCB is required to submit an annual report to the Office of the State Budget Director and the General Assembly's Interim Joint Committee on Appropriations and Revenue setting forth the activities of the CVCB for the preceding state fiscal year, including a complete operating and financial statement. OCA has not yet completed and submitted the FY23 annual report.

12. **Please provide any additional comments that are helpful to improving the Victim Compensation state and/or federal program.**

The expected funding decreases to VOCA are certainly troubling. It is very important that these issues be addressed quickly so that state compensation programs continue to receive much needed funding for their programs through VOCA. No state's compensation program can afford to adequately fund itself through state monies alone.
