1. Please explain any significant change in the number of applications received during the reporting period.

The Texas CVC Program saw a decrease in victim applications received and an increase in sexual assault exam applications received during the reporting period. This was the fourth year of processing sexual assault exam applications directly from health care providers as required by a legislative change.

The Texas CVC Program calculates the days to process an application for claim eligibility from the date the application is received to the date an eligibility determination is made. If an application is received without needed victim, claimant, or crime information, the program requests the necessary information and may place the application in suspense.

For most of this reporting period, the Texas CVC program continued to be impacted by staffing shortages. This affected a few of the production areas involving application processing, eligibility determinations, and payment processing.

5. Please describe in detail efforts taken to serve Victims of Federal Crime during the reporting period.

The Texas CVC program continues to assist federal victims of crime in the same fashion we do for all victims.

6. Please describe any notable activities during the reporting period that improved the process of victim compensation services.

The Texas CVC program has made continued improvements to the Crime Victim Management System (CVMS) web portal which provides victim registration for online accounts, an enhanced online application, the capability to upload documents into claims, and enhanced online views for victim advocates and medical providers.

Please describe in detail ways in which your state used VOCA Administrative funds and the impact of these funds on the state's ability to improve victim compensation services during the reporting period.

VOCA Administrative Funds were used in FFY2023 for modifications, support, and enhancements to the online CVMS web portal that allows applicants to apply and manage their claims online.

8. Were there any laws, initiatives, or policy changes in your state regarding victim compensation during the reporting period? If yes, please briefly describe them and their impact.

The Texas Legislature passed two major pieces of legislation during the 88th Legislature - SB 49 and SB 1401. SB 49 amended the Code of Criminal Procedures regarding certain expenses under the Crime Victims Compensation Act. The bill removed the need that a family member be an immediate family member as a claimant for crime victims compensation and expanded the definition of family violence towards a child of the family or household and dating violence. Additionally, the bill removed the 10-day limit for bereavement leave for a family member or household member of a deceased victim and expands who is eligible for reasonable and necessary costs for relocation and house rental assistance payments, removed statutory limits for relocation, housing rental expenses and adds expenses for temporary or emergency lodging. The bill requires the Office of the Attorney General to award no more than one victim and one claimant, or two claimants if the victim is deceased, regarding the same criminally injurious conduct unless the OAG determines it is necessary based on the extraordinary health or safety needs of the victim or claimants, and establishes a new limit that any victim or claimant may receive to \$5,000 in the aggregate for relocation expenses and housing rental expenses and an award a family member or household member may receive for bereavement leave to \$3,333 in lost wages. SB 1401 amended various provisions in the Code of Criminal Procedure, Family Code, Government Code, Health and Safety Code, and Occupations Code relating to the rights of victims of sexual assault and to certain procedures and reimbursements occurring with respect to a sexual assault or other sex offense. The bill removed the requirement that the offense must be reported to a law enforcement agency and the forensic medical exam must be conducted by a health care provider and removed the 120-hour requirement for forensic medical examinations of a victim of sexual assault in certain circumstances. The law requires a law enforcement agency to refer a minor regardless of timeframe and allows them to refer a victim outside of the 120-hour requirement if it may further a sexual assault investigation or prosecution. Adds that any costs related to the testimony of a health care professional regarding the forensic

medical exam results in the criminal case may be paid by the law enforcement agency or the Office of the Attorney General representing the state. Requires the OAG to pay reasonable costs incurred for testing and medical care for a victim of sexual assault according to specific articles and medical fee guidelines, not exceeding \$25,000. Allows HHSC to contract with a third-party vendor to provide health care providers access to prescription drugs for medical care related to a sexual assault and requires the Texas Department of Criminal Justice to develop procedures for the transfer and preservation of evidence collected during a forensic medical examination for sexual assault cases, as well as establishing requirements and procedures for preservation of evidence. Finally, the law provides that a victim receiving a forensic medical exam is considered sufficient evidence of cooperation in the investigation of a sexual assault. The OAG could use the Compensation to Victims of Crime Fund to make payments for reasonable testing costs to, or on behalf of a victim of sexual assault.

9. Please describe system-coordination efforts with prosecutors, law enforcement, courts, U.S. attorneys' offices, tribal systems, State VOCA Victim Assistance Coordinator, or other key personnel within the criminal justice system in your state to reduce barriers to victims who may apply to receive victim compensation.

The Texas CVC program provides training for law enforcement, prosecutorial offices, victim advocacy groups and service providers on the Rights of Victims and the Crime Victims' Compensation program including eligibility and claims processing. Additionally, Texas has three regional coordinators who are responsible for implementing professional training programs for criminal justice professionals. Finally, the Texas OAG provides grants with state funding of \$2.81 million in state fiscal year 2023 to fund victim assistance coordinators and crime victim liaisons located within police departments, sheriffs', and prosecution offices. These positions provide direct services, assist with applying for compensation, and understanding victims rights.

10. Please explain any public outreach efforts to improve awareness of your program.

The Texas CVC program provided online training to 1,068 participants during the reporting period. Additionally, outreach was provided to 101,302 recipients. This includes outreach through our website.
